Sunnyside Recreation Area used to be known as Sunnyside Farm. Who were the last private owners, and what were they well-known for?

Answer to Last Month's Question:
George "Snuffy" Stirnweiss was a Major League
Baseball player who bought a house in Lincroft in

1947. He decorated one room with bats that were sawed in half lengthwise (one of which is in the MTHS collection). The former Yankee won his league's batting title in the war-depleted year of 1945 with just a .309 average, one of the lowest averages to ever claim the title. Stirnweiss, aged 39, died in the 1958 railroad Central Railroad accident that plunged it into Newark Bay. He is buried in Mt. Olivet.
